

Please find below the information we provide to U.S. citizens, Lawful Permanent Residents (LPRs), and Immigrant Visa applicants for whom our Team at CA is working to develop evacuation options and guidance.

We have been able to confirm the information of the seven (7) families you provided and are listed below, Also, please note that our relocation efforts for Amcits/LPRs is limited to only their immediate family (spouse, parents of minors, and children under the age of 21.) Some of those listed above do not fall into this category.



Regarding and his family, we would appreciate it if your office could provide any additional biodata, including their dates of birth and passport numbers.

I have pasted below the current instructions and guidance we have for U.S. citizens, LPRs, and Immigrant Visa applicants, below. Please pass on any further updates so we can track and coordinate as best as possible.

The U.S. Embassy in Kabul suspended operations on August 31, 2021. While the U.S. government has withdrawn its personnel from Kabul, we will continue to assist U.S. citizens and their families in Afghanistan from Doha, Qatar. We will also continue our efforts to help Legal Permanent Residents, as well as the many Afghans who have stood with us over the years, who are seeking to leave Afghanistan.

Our commitment to the people of Afghanistan is enduring. We will continue to press for an orderly transition of power to an inclusive government with broad support, especially women and minorities. We will use every diplomatic, economic, political, and assistance tool at our disposal to uphold the basic rights of all Afghans; support continued humanitarian access to the country; and ensure the Taliban honors its commitments.

U.S. citizens and their family members still in country should:

- Enroll in the <u>Smart Traveler Enrollment Program (STEP)</u>
 to receive security updates and ensure you can be located in an emergency.
- Review your personal security plans.
- Be aware of your surroundings and local security developments at all times.
- Keep a low profile.
- Notify a trusted person of your travel and movement plans.
- Make contingency plans to leave when it is safe to do so that do not rely on U.S. government assistance.
- Monitor local media.







Dear Christopher,

We have known American Citizens and LPRs left behind, abandoned by their government, hiding in Kabul. The early victory lap by the State Department earlier today was abhorrent while your agency knows of current cases on the ground that have been left stranded.

Congressman Issa requests an immediate meeting with State Department officials to receive a briefing on the steps being taken to return our citizens home to safety and answer questions as to the methods being employed.

This meeting is urgent as American lives are in immediate danger with apparently zero support from their government who promised to bring them home.
